1. Dance competition will be run in accordance with the rules of the SOBHD
2. First to enter Last to Dance rule applies
3. Highland and National points will be combined to determine aggregate trophy winner
4. Decision of the judge is final
5. All age groups will be determined at the close of the entry
6. All groups will receive medals and cash prizes will be awarded to premier dancers
8. An Aggregate trophy will be awarded in each class, except primary as long as there are at least three dancers in the age group.
9. Current year FUSTA Card is required to compete.
10. Advance registration is necessary. Entries must be postmarked by May 20, 2018. Entries received after May 30, 2018 will be considered late and a \$10 late fee needs to accompany the entry. No entries will be accepted after June 5, 2018. No exceptions.
11. Any protest must be submitted in writing to the competition organizer, properly signed and accompanied by a fee of \$20. It must be made immediately following the competition. If the protest is sustained the fee will be returned.
